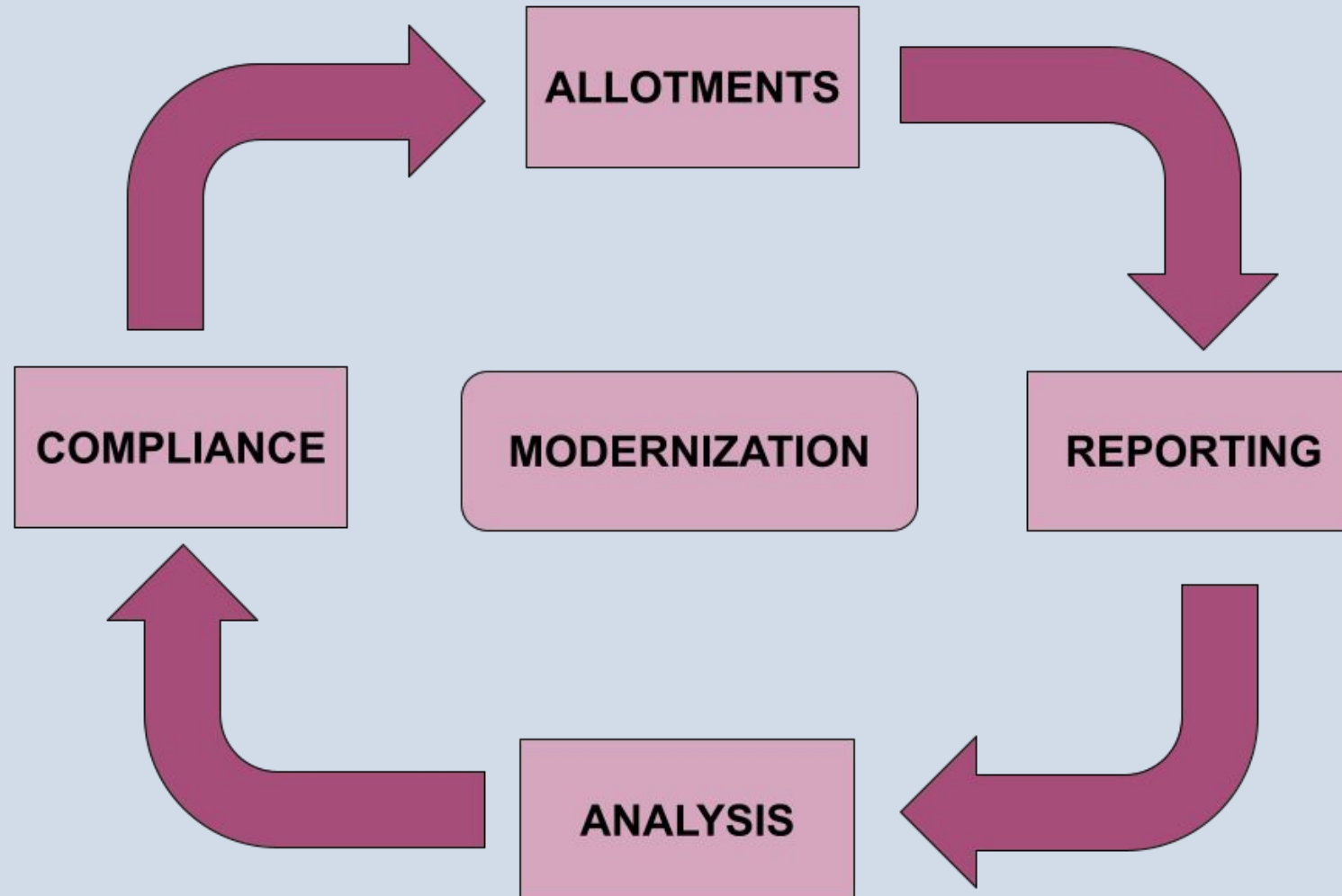

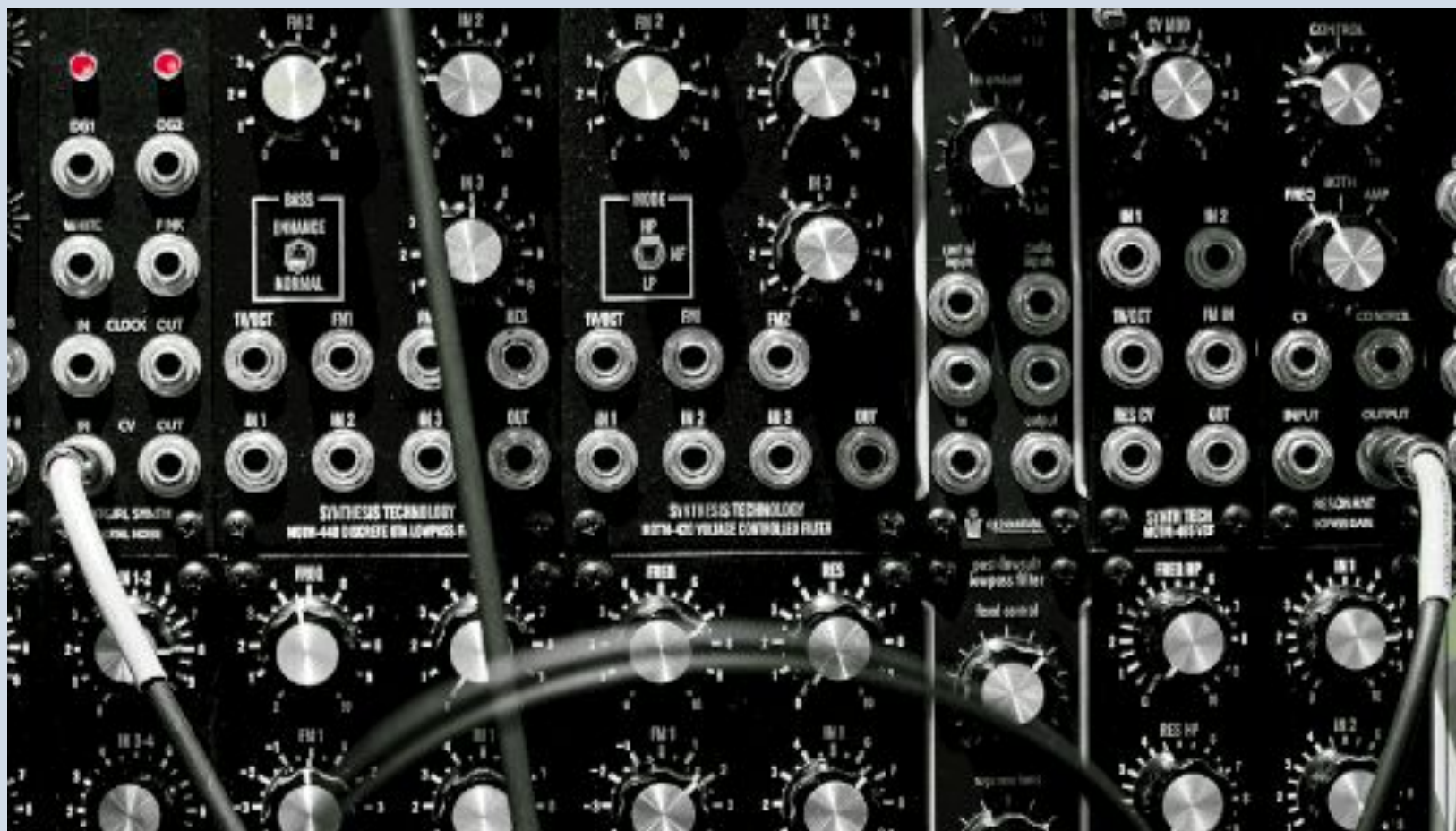
SCHOOL BUSINESS SERVICES

- Allotments
 - Allocates the funding to all PSUs
- Analysis
 - Provides analysis and reports to internal partners, OSBM, General Assembly, the USED, research partners, and to school districts
- Compliance
 - Ensures PSUs are fiscally compliant with any state and federal regulations
- Reporting
 - Collects, organizes, and validates UERS data files

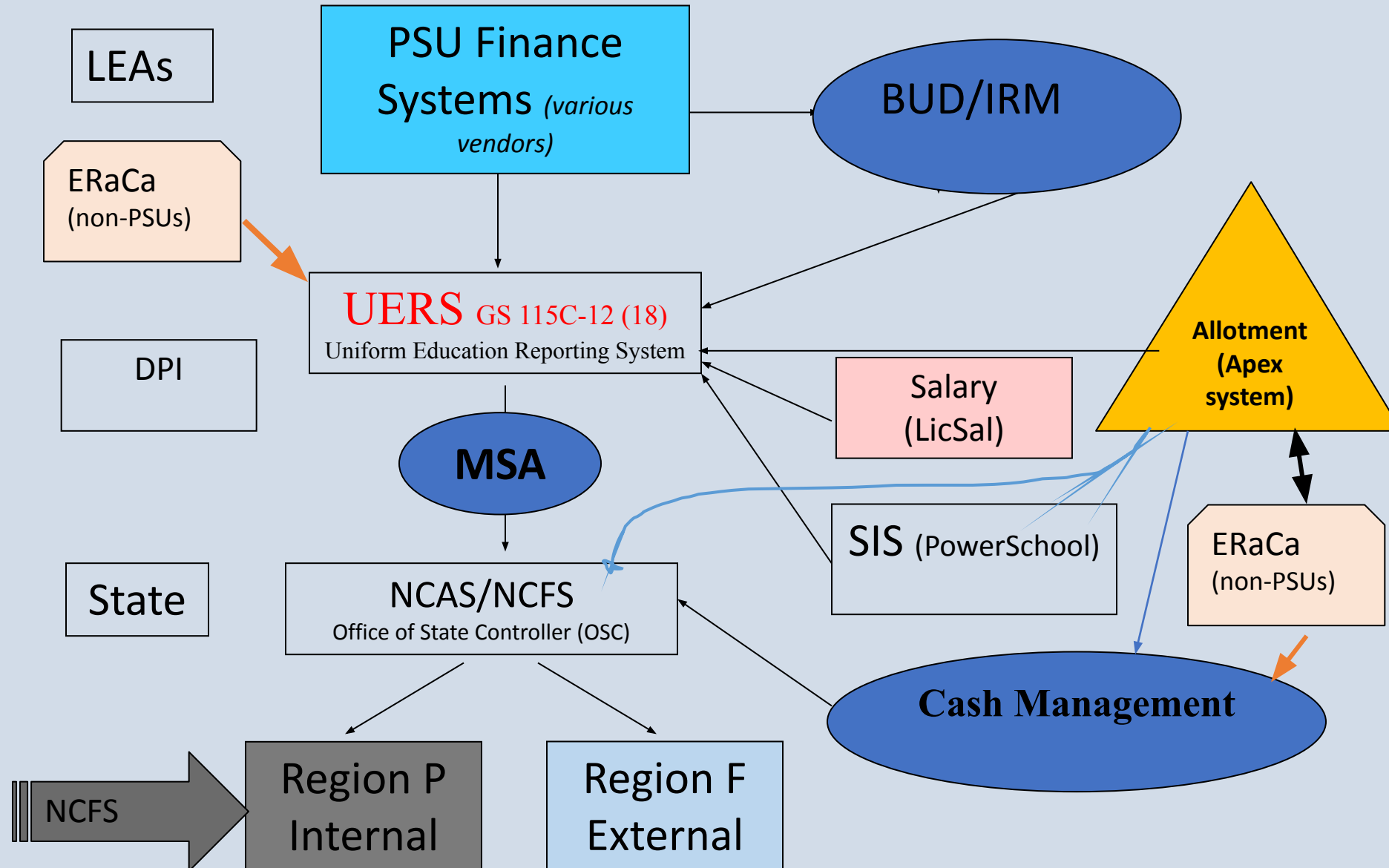

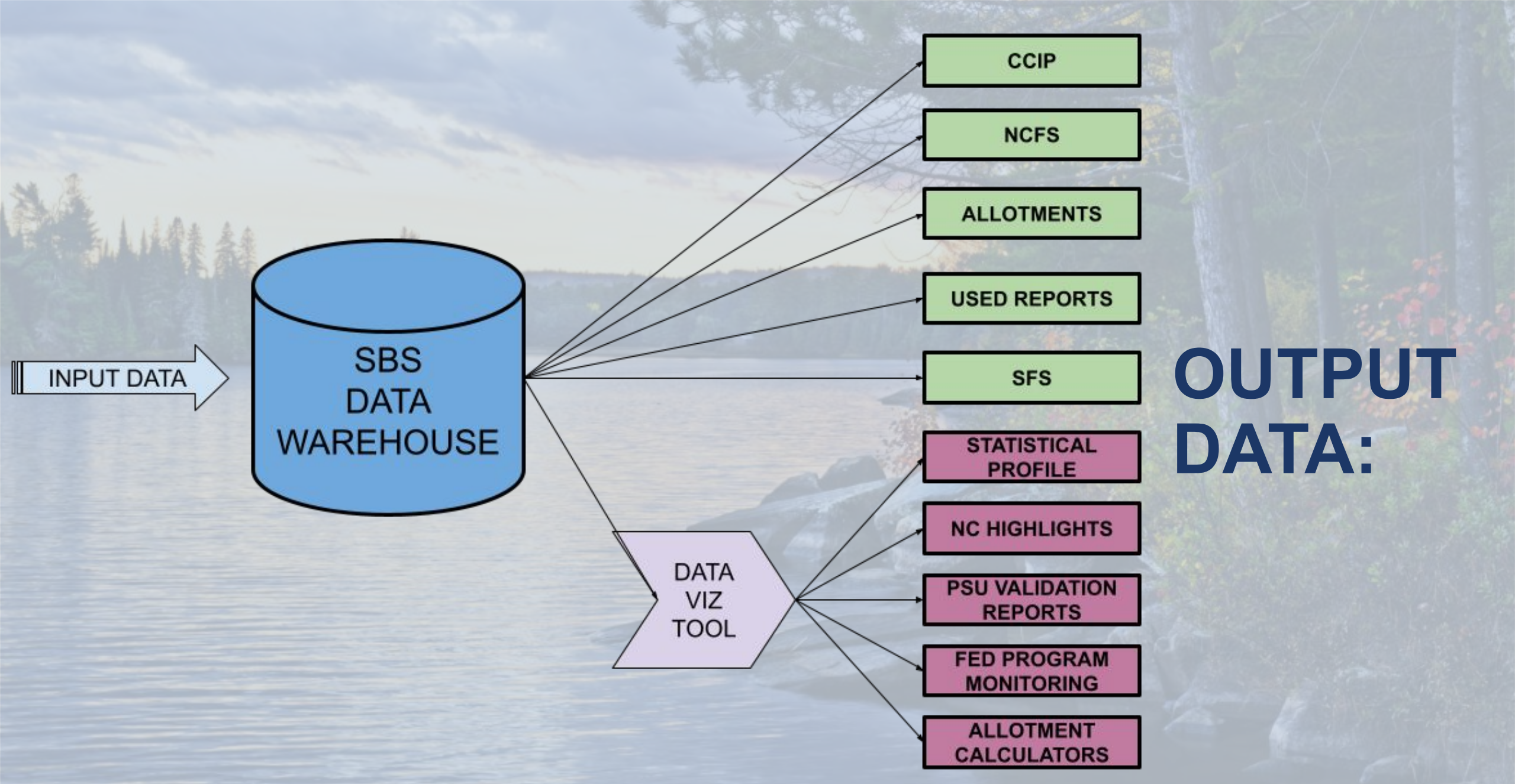


INPUT DATA: PHASE 1

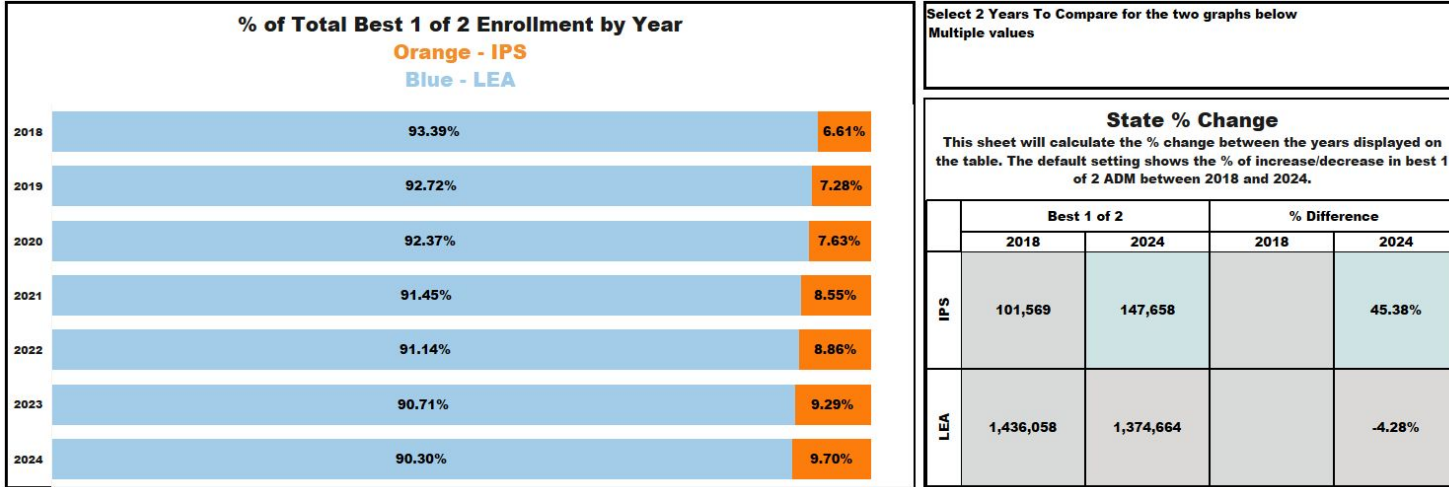
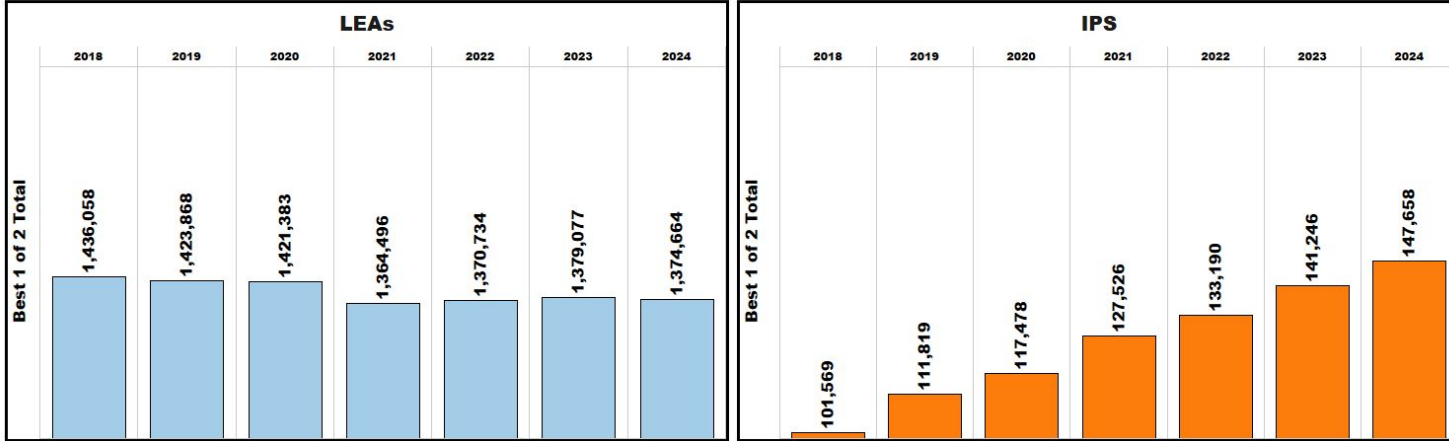

Trends in Independent Public Schools compared to Traditional Local Education Agencies 2018-2024



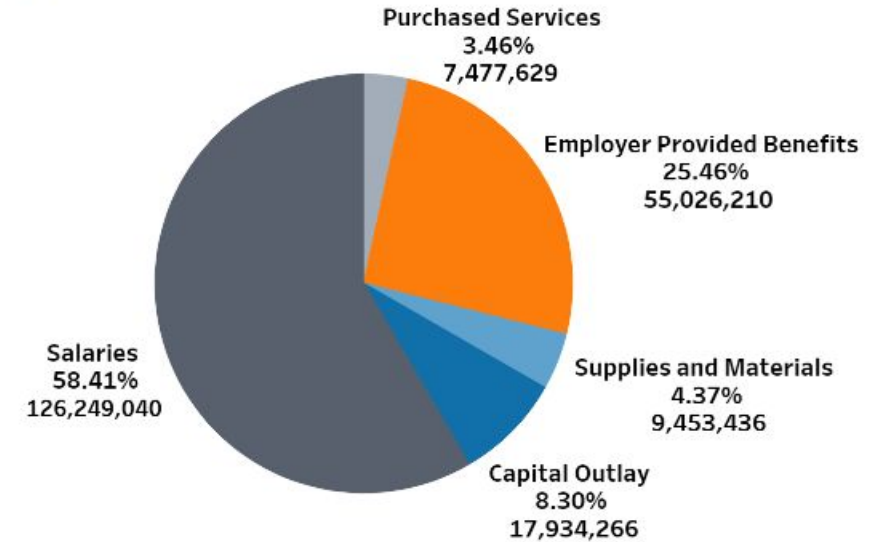
